Statement for Triple Point IGF LLP and Triple Point IGF 2 LLP [referred to as the LLPs] in response to the FCA's Sustainability Disclosure Requirements (SDR) and rules on investment labels.

Triple Point IGF LLP and Triple Point IGF 2 LLP (the LLPs) are investment vehicles established by Triple Point.

The LLPs were established with the investment objective to provide access to Imbiba Growth 1 LP and Imbiba Growth II LP (IG1/IG2) to a specific set of investors.

The LLPs fall within the definition of a feeder Alternative Investment Fund for the purpose of the FCA rules. The LLPs are closed to new members and are classed as closed products.

The LLPs feed into IG1 and IG2 which are the master AIFs managed by Imbiba.

Imbiba is authorised and regulated by the FCA (Reference number: 815761) as an Alternative Fund Manager to manage unauthorised AIFs - they are a small authorised UK AIFM.

In accordance with the FCA rules, as the manager of the AIF Master Fund into which the LLPs are invested, Imbiba is the entity responsible for adhering to the consumer-led disclosure requirements of the SDR in respect of the LLPs (if applicable).
